- *EMS Captains and government meeting with Chief's went very well. Supervisors, mayor, EMS officers reviewed info on what's happening with EMS in the county. Floor opened up for conversation, all reps there except a few. Monroe available assets will be changing soon. Basic changes.
- *Update on Springville paid EMS provider operations. RMA and Mercy EMS stationed at Springville at this time. RMA will be the first resource available to Wyoming County, and if not available Mercy EMS will be the second dispatched if needed. Mercy Ems only holds a Emergency CON for the Village of Springville and the town of Concord at this time. Mercy EMS is going through the CON process at this time.
- *New Hazmat training looking good. Big changes coming with how we train head people, techs, etc. and tests.
- *Update on crude oil transportation. No Crude oil being transported through Wyoming County at this time. Foam trailers have been deployed across NYS for emergency purposes. Olean is our closes unit at this time. More foam trailers will be deployed as needed across NYS.
- *Review new 2016 meeting schedule. All agreed to it except Chief's and their meeting is this month.
