\*Received certificate for 2016 fire reporting, 100% This is where we get our money for training.

\*Review 2017 fire reporting to date. 3 departments haven't submitted anything yet for the whole year.

\*ECMC & WCCHS dinner & training went really well. Had 80+ people attend at Hidden Valley. \*Plenty of low interest \$\$ available for projects. \$12 million out there to use for upgrades on fire

stations, turn out gear, apparatus.

\*Firefighter Officer class to be broken down to 5 segments. modular formats. Was 63 hours long New one will be out in the next 3 months.

\*State fire update on WEB site. Need to update all info in your system. Members who have died, quit, moved on, disappeared.

\*Fire data in NYS: went over data on fire calls etc.

\*SPTC to have swift water training in spring. \$11 million put into it.

\*UAS (unmanned aerial systems) drones, only troopers, and DEC assigned these. Yates County doing a one night training on when you can use them and for what.

\*Best practices in Wyoming County went well. 90+ attended and 16/18 departments participated.Very happy with excellent turn out.

\*Review FF physicals for 2018.Changing around to eliminate long lines. Strykersville, North Java, Sheldon, Harris Corners, Cowlesville, Bennington, Arcade. Just these departments only. The rest will be: Varysburg with Attica, Perry with Perry Center, Gainesville with Silver Springs and Castile, Pike with Bliss, and Warsaw with Wyoming, and County Hazmat at work place health.. List out soon with times etc.
