MINUTES: 6/13/2022

*On June 13, 2022, at the TC the FAB was called to order at 7:32 p.m. by Chairman Joe Cummins.

*Pledge to flag recited followed by a moment of silence for those deceased.

*Minutes of previous minutes read and accepted.

*Treasurers report read and accepted. All dues are in.

*COMMUNICATIONS: NOTHING

*RECRUIT AND RETENTION: Nothing much, Letchworth was better this year. Warsaw too. Targeting 14-16 year olds in schools.

Possible three (3) seats available if the towns are not included since all towns with no Fire Company's based in their town can have a seat. See if someone is interested or go to delegates from each group? Decided to wait till next year who to put in these spots.

*Steak Roast, September 12 @ North Java—6 cocktails & 7 dinner. Discussed to have people do a dish to pass or have it catered again. Decided to cater again with Catered Creations. Bill to set up. Set up for \$500 budget. Raise FAB dues to \$50 starting in 2023. Approved. Raise steak roast dinner to \$20 per person. Approved.

***WY-52 REPORT:**

*Received just under \$600,000.00 for Training Center renovations from US Congressman Chris Jacob's. Looking at next spring to start, Training will need to be elsewhere. Starting in March till October. Will need to abandon this building for meetings. Burn building will still be available for use.

*Will be hiring 2 more—SFI & 1-SFSI soon. Need proper classes to qualify. Lance Scharlau resigned. Fall instructors conference hopefully offered regionally.

*County Burn room is offline for 2-3 months. Needs \$34,000.00 worth of total repair.

- *Mental Health for First Responders—Wyoming County Program—6 competed the training. Canceled the 2nd class. Participation to low. Moving forward with program.
- *We've got your 6 Responders Ride & Rally, June 26. Start at Charcoal Coral. Open to all responders. Supports shop with a cop program in Wyoming County.
- *If you need to access the Warsaw Airport, contact dispatch for the code.
- *Discuss what is needed when your agency is requested for a stand-by. Needs to be stepped up with interior firefighters to fight other fires if needed.
- *Legislation moving forward for FF recruitment & retention & subcommittee update. Slowed down, extension granted.
- *Award letters for our convention are due June 16, 2022 so get them in to Bill Perl.
- *State Chief's Conference is June 15-18, 2022 at the on-center in Syracuse, NY
- *New Fit testing machine has arrived. Working on getting data switched over. Will be resuming testing soon.
- *Foam updates: Do not use the foam (AFFF) you have in hall. Need green foam. F-600 is not a foam, it's an emulsifier.
- The ID machine should be up soon. (All new pictures). Old pictures and data still there.
- *Cancer paperwork due at end of last year. 6-departments did it, 5-departments did part of it and 7-departments did nothing at all. (They didn't feel they needed to do it) Bill to reach out to these, push it out more.
